1. WFOT Executive Management Team Meeting (EMTM), March 2017

The annual EMTM was held in Philadelphia, USA, in late March. This four day meeting focused on the business of WFOT, addressing ongoing priorities, projects and matters raised by Member Organisations.

Some of the outcomes for the EMT include:

- Strengthen the collaboration with WHO and other international stakeholders
- Formalise reciprocal arrangements with International NGO's including Handicap International and ISPO
- Preparation of the Strategic Plan 2019 2024
- Develop action plan for Rehabilitation 2030 to encompass all sectors for delivery
- Strategy to maximise impact of the Advocacy Toolkit for the International Labour Organization to recognise occupational therapy as a profession
- Progress the promotion and delivery of the requirements for the Congress 2018 in line with the critical path
- Extend the range of Position Statements and associated global surveys
- Progress the Assistive Technology Master Plan
- Revised strategic Mental Health Master Plan and collaboration with WHO
- Implement the MSEOT (Revised 2016), and action translations
- Undertake a comprehensive review of website functionality and datasets in preparation for the launch of a new website and management tools
- Extend the range of WFOT online networks and learning opportunities, together with the Occupational Therapy International Online Network (OTION)

An Actions list will be circulated as part of the Agenda for Council Meeting 2018.

2. WHO/WFOT Collaboration

WFOT President Marilyn Pattison and Executive Director Ritchard Ledgerd attended the WHO high level meeting 'Rehabilitation 2030: A Call for Action' in Geneva in February 2017. During the meeting the following statement was submitted:

- <u>Statement in response to WHO Rehabilitation 2030 a Call for Action Plan</u>
- During the meeting it was identified that collaboration between health professionals and consumer/patient/client could be achieved through the development of a global

rehabilitation consortium with stakeholders from a range of backgrounds forming a collaborative model of engagement. It was agreed that:

- Global professional organisations would generate unified statements, using consistent terminology in support of interdisciplinary, evidence-informed rehabilitation practice.
- Such a consortium or collaboration would provide technical support as required to inform the development of policy.
- National organisations should be encouraged to work collaboratively especially where there are multiple organisations with common purposes.

WFOT is already an active participant in this consortium:

- Statements were also submitted to the WHO 140th session of the Executive Board (January 2017):
 - Statement in support of Promoting the Health of Migrants
 - o Draft global action plan on the public health response to dementia

WFOT's collaboration with WHO is one of the pivotal activities WFOT engages in. WHO is part of the **United Nations** and as a result WFOT has a direct collaboration via the UN as a member of the **DPI/NGO** international network through its **Global Compact** agreement. WHO provides WFOT with a direct overview and global interaction mechanisms pertaining to international policy and directives that are mandated to WHO Member States.

3. United Nations (UN)

As part of the requirements for ongoing relations with the UN, WFOT prepared an annual report that was submitted in January 2017. Many of the requirements of the report are focussed on the activities that the partner organisations are undertaking to support the UN Sustainable Development Goals (SDGs). WFOT will continue to track such activities and include the relevant SDGs in WFOT programme and project plans and provide the information directly to WHO.

WFOT also supports the United Nations by regularly publishing information about key International Days celebrated by the UN and WHO at <u>www.wfot.org</u> >News. Examples include World No Tobacco Day, 31 May 2017; World Day for Cultural Diversity for Dialogue and Development, 21 May 2017; and World Day for Safety and Health at Work - 28 April 2017. A schedule of these days is available at <u>www.wfot.org</u> >Resource Centre, 'Key Dates for your Calendar'. Member Organisations are encouraged to support WFOT's collaboration with the UN and WHO by promoting these significant days.

4. International Society for Prosthetics and Orthotics (ISPO)

WFOT has recently signed a formal partnership agreement with the ISPO to promote collaboration and cooperation between the two organisations to contribute to a better world for persons with disability. WFOT has previously had informal collaboration with ISPO on areas such as staffing for instructional courses and presentations at conferences. WFOT Executive Director Ritchard Ledgerd attended the ISPO Open Board Meeting and Conference in May, in South Africa, to progress areas of mutual interest. 5. Handicap International (HI)

WFOT has also entered into a formal partnership agreement with Handicap International (HI). This partnership aims to 'cooperate to contribute to a better world for people with disabilities, to improve the quality of life of people with disabilities, and to influence the development of occupational therapists within the global health professionals community

for a direct contribution to improve the quality of life and empowerment of people with disabilities and vulnerable populations through activity and assistive technologies.' For information on Handicap International, go to <u>http://www.handicap-international.org/</u>

6. <u>Cochrane Rehabilitation</u>

WFOT has been invited to join the Cochrane Rehabilitation Advisory Board. Cochrane Rehabilitation serves to drive evidence and methods developed by Cochrane to the world of Rehabilitation and to convey priorities, needs and specificities of Rehabilitation to Cochrane. WFOT is delighted to accept this invitation, and looks forward to enabling occupational therapy to be represented at this level and a fruitful collaboration. WFOT Interim PCo Research Dr Liliana Alvarez Jaramillo will be the lead person for WFOT involvement with Cochrane Rehabilitation.

7. International Labour Organization (ILO)

WFOT has completed the advocacy plan for lobbying the ILO regarding the description of occupational therapists in the International Standard Classification of Occupations (ISCO). A tool kit has been circulated to Member Organisations for implementation in their countries. Thank you to Member Organisations who are actively supporting this lobbying campaign – we hope this leads to the reclassification of occupational therapists in the next edition of the ISCO.

8. Minimum Standards for the Education of Occupational Therapists (MSEOT) (Revised 2016)

The MSEOT (Revised 2016) came into operation in January 2017, and following engagement with WFOT Member Organisations and other key groups, a detailed plan for all aspects for the international implementation of the MSEOT (Revised 2016) was agreed at the recent WFOT Executive Management Team Meeting 2017, in Philadelphia USA.

Maintaining a comprehensive list of current and historic approved education programmes on the WFOT website is an integral part of the organisations business. As WFOT embeds the implementation of the MSEOT (Revised 2016) an upgraded website with automated functionality is being developed to support this process

WFOT is particularly grateful to the several Member Organisations who have already offered to support the translation of the MSEOT (Revised 2016) into their national language. This support will ensure that the WFOT educational standards can not only be implemented at national universities, but in addition can be provided to the governmental agencies in these countries to ensure that the education of occupational therapists can be of the highest standards, and have an international endorsement.

9. Disaster Management for Occupational Therapists (DMOT) online module

WFOT was pleased to announce the launch of the new online module – 'Disaster Management for Occupational Therapists', at the end of May. – Information was circulated to Member Organisations and Higher Education Institutions, and posted on the WFOT website and social media channels.

The launch was celebrated by offering a free copy of the textbook 'Disaster and Development: An Occupational Perspective' to the first 100 people who purchased the online module.

The launch of this online module is a significant achievement for WFOT, and I thank all who were involved in its development and testing. WFOT looks forward to developing further educational modules in the future.

10. WFOT Bulletin

Thank you to Member Organisations and Delegates who responded to the call for the nomination of occupational therapists to review manuscripts for the WFOT Bulletin (December 2016/January 2017). A significant response was received, and the nominations are being followed up.

The WFOT Bulletin volume 73 issue 1 (April 2017): "Working with children" is now available online via the WFOT website. This volume features a guest commentary in Spanish by Enrique Henny (Chile). It includes the report of the WFOT Human Resources Projects.

Four articles follow the theme of working with children and their families, and one relates to working with refugee adolescents. Articles on occupational therapy education complete the issue.

11. WFOT Congress 2018, 21-25 May 2018

The deadline for submission of abstracts has passed and a total of **2457** abstracts from around the world was received. 11.6% of the abstracts received were from Africa – this is an exciting outcome when we consider that African occupational therapists equate to 1.24% of occupational therapists internationally (WFOT Human Resources Project 2016). Abstracts are currently being reviewed by an international team of over 200 occupational therapists.

The WFOT Grants programme was established for the Congress in 2006 in Australia, to assist attendance at WFOT Congresses and it has been used for every Congress since then.

The aims are to:

- raise funds to support the attendance of delegates in low / middle income countries
- ensure that successful applicants demonstrate a commitment to professional leadership through disseminating the learning on returning home; this may be in an association, academic, research or clinical context
- focus on providing access to as many in-country delegates as possible to attend the Congress, with the view to extend assistance to other low / middle income countries.

The WFOT Grants programme is open for Congress 2018 in South Africa, again to support African and other colleagues to attend this exciting event in Cape Town. This programme is based entirely on donations and is designed to respect the contribution the awardees can make and encourages occupational therapists to talk about their local practice settings as well as utilise the information gained on their return to their home country.

The options for donating are:

- 1. Congress registration process When you complete a registration form to attend the congress, there will be an option to contribute your preferred amount to the Grants Programme.
- Online contribution form A 'Grants Contribution' link will be set up on the Congress website to enter in your contribution details and preferred payment method. (Information coming soon).

WFOT Executive Director Ritchard Ledgerd and Vice President Finance Samantha Shann visited Cape Town South Africa in late February/early March. A week of productive meetings addressed organisational arrangements for the WFOT Congress 2018, and the Executive Management Team and Council meetings scheduled for the week prior to Congress. Thank you to colleagues in South Africa for hosting this visit, and for working hard to provide an exciting and stimulating programme in Cape Town, May 2018.

Whilst in Cape Town attending the ISPO Conference, Ritchard Ledgerd also met with the Occupational Therapy Association of South Africa (OTASA) and local organisers of the WFOT Congress 2018.

Sue was WFOT delegate 1973-1981; attended the 1974 council meeting in Canada, 1976 in Paris, 1978 in Israel and 1980 in South Africa. Her roles in the WFOT included Chair of the Legislation Committee 1976-78, 2nd Vice President 1978-82 and 1st Vice President 1982-86.

Freda Jacob, Australia, passed away May 2017.

Freda served on several WFOT committees over many years.

She was WFOT Assistant Secretary/Treasurer 1962 – 1970. In 1970 Freda was elected Chair of the Legislation Committee

Following twenty years of service to WFOT, Freda was awarded an Honorary Fellowship in recognition of her significant contribution to WFOT at the 15th WFOT Council Meeting in Amsterdam (Netherlands), in 1982
